

The property is conveniently located in a rapidly gowning area of Charlotte's University City area. University City is within the city limits of Charlotte, NC surrounding the University of North Carolina at Charlotte campus. The property is positioned in northeastern Mecklenburg County on N Tryon St/NC 29, a main thoroughfare linking Uptown Charlotte with the University area. It is located less than a mile from I-485, providing convenient access to I-85 and I-77.


In 2019, the LYNX Blue Line was extended from Uptown Charlotte to University City. It is neighbored by the town of Harrisburg to the east and the city of Concord to the northeast. Attractions along University City's outskirts include Charlotte Motor Speedway and Concord Mills Mall. University City is home to the University Research Park (located on the other side of I-85), one of the largest research parks in the state, and the PNC Music Pavilion.

Regional Map






N. Tryon St. Office Site Plan | 06
