Okehampton is a town and civil parish in West Devon. It is situated at the northern edge of Dartmoor and has an estimated population of 7,500 (2011 census) which is boosted over the course of the year by tourism. The town's retail catchment is extensive due to the lack of competition, located approximately 31 miles north of Plymouth, 23 miles west of Exeter and 29 miles south of Barnstaple.


