LOCATION

The property is prominently located on the north side of Union Street, Aberdeen's main commercial thoroughfare, close to its junction with Market Street. The unit is directly opposite what is recognised as the prime pitch of Union Street, and is anchored to the east by the St Nicholas and Bon Accord shopping centres, the Trinity Centre to the west, and Union Square to the south.

Surrounding occupiers comprise a mix of retail, professional services and leisure use and include **O2, Three, Caffe Nero, Marks & Spencer, Sports Direct, Clydesdale Bank, HSBC, Size?, Lush, Ecco and Dr Martens.**

DESCRIPTION

The subjects comprise a ground floor retail unit with basement storage which is contained within a traditional, mid-terraced 5 storey and mansard building of granite construction with a pitched and slate covered roof. The upper floors are used as office accommodation and are separately demised.

Internally, the ground floor accommodation comprises a main sales area with storage cupboard to the rear. The basement is accessed via a stair to the rear and provides a manager's office, ample storage space, staff area with small tea prep and single WC.

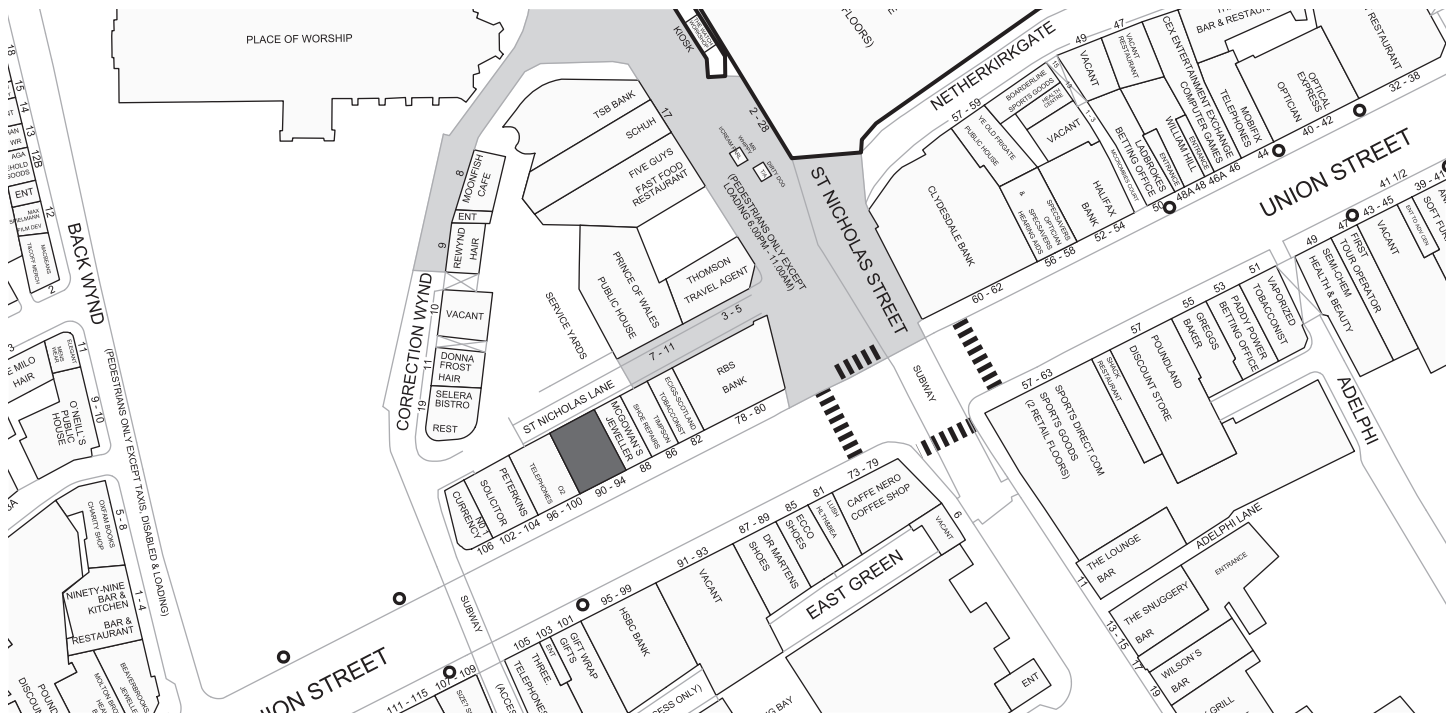
