#### **LOCATION**

Peterborough is an historic cathedral city in the east of England. It is the largest city in Cambridgeshire with a population in excess of 190,000 and is currently the fourth fastest growing city in terms of population in the UK.

The property is located on Papyrus Road just of the A15 and approximately 2 miles from the A47 (Peterborough Parkway) providing access to the A1 and the city centre.

#### **DESCRIPTION**

The property comprises an industrial / business unit of steel portal frame construction with brick clad elevations under a pitched roof. Internally the unit includes a full span mezzanine floor. 
