#### LOCATION

Point 5 is very well located on Fletcher Road in central Gateshead, only a one minute walk from the High Level Bridge and ten minutes from Newcastle Central Station. The Trinity Square shopping and leisure development can be reached within a short walk providing both superb local amenities and also a bus and metro interchange.

The cultural and leisure facilities on Gateshead Quayside, including the new By The River container park, Sage, Baltic and the Hilton are within in 5 minute walk from Point 5 offering a superb location for business and staff.

Point 5 is a two storey former Victorian railway building that has been superbly restored to provide approximately 3,231 sq.ft. of Grade A office space.
