

LOCATION

Verlon Trading Estate is within Barry's most established industrial business location.

The Estate is accessed from Cardiff Road. Set just off the main road the available units are located at the top of the site. The wider area has attracted a mix of users including offices, trade counters, warehousing and leisure including a nearby play centre and a McDonald's Restaurant.

The estate is approximately 10 miles from Cardiff and within easy access of the M4 Motorway

(Junction 33) via the A4050 and A4232.

DESCRIPTION

The units are of steel portal frame construction with lower elevations of brickwork. The upper elevations and pitched roof are of profiled steel sheet cladding.

Internally the accommodation benefits from flourescent strip lighting and a minimum eaves height of 4.6m.

Vehicular access is provided via level access roller shutter doors.
