



LOCATION

Church Square Shopping Centre dominates retailing in St Helens and comprises of two separate elements, St Mary's Arcade and Lagrange Arcade which is the prime fashion destination in St Helens.

The Centre offers a 280 space multi-storey car park and is anchored by **BHS Department Store** and **Boots**. National retailers include **Superdrug**, **Topshop**, **Fat Face**, **JD Sports**, **River Island**, **Thorntons**, **H Samuel**, **Pandora** and **H&M Hennes**.

The unit is situated on pedestrianised Church Street and is in close proximity to **Savers** and **Costa Coffee**.

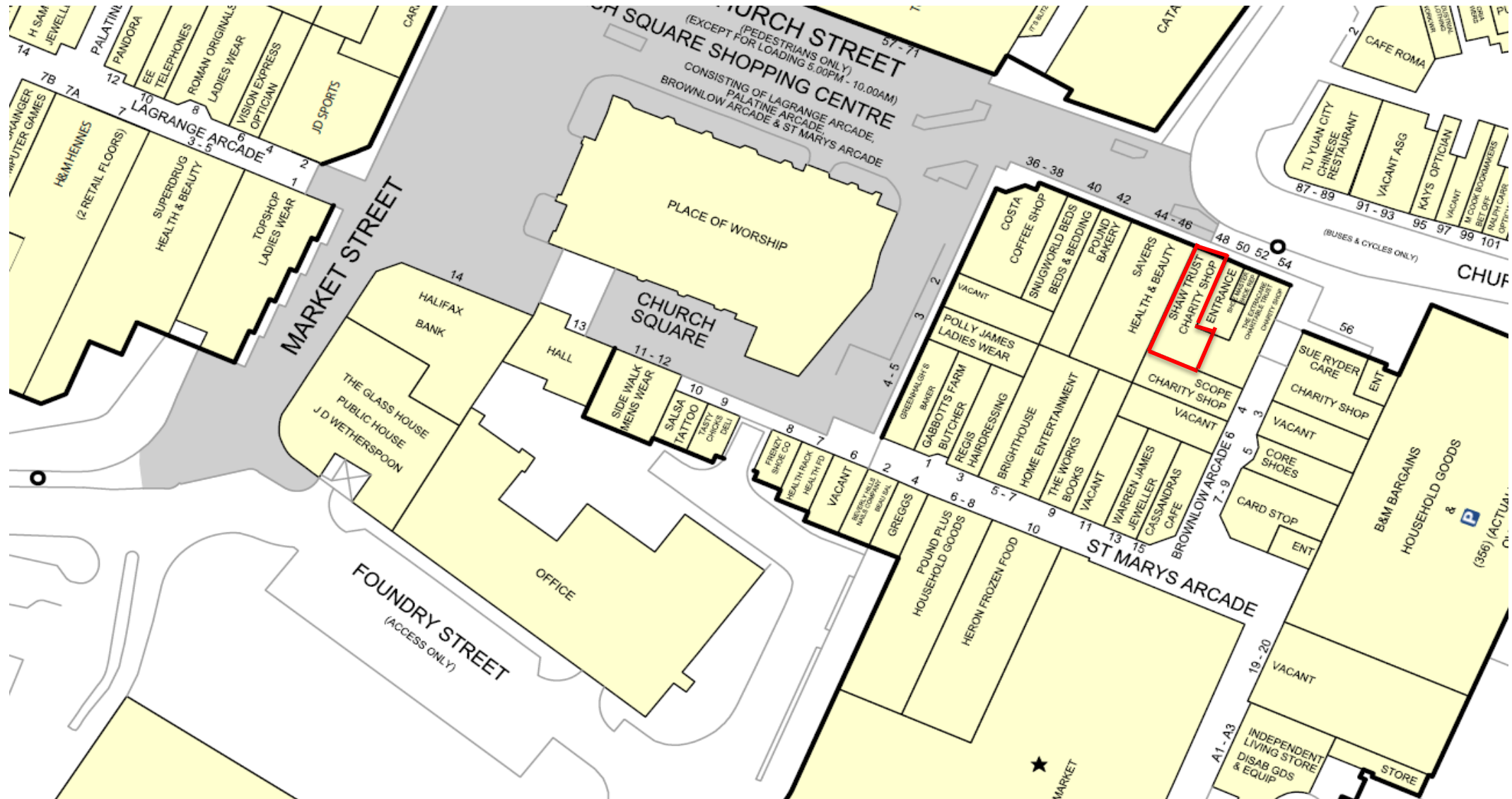
