LOCATION

Unit 18 is located on the established Abercrombie Court Business Park on Arnhall Business Park, Westhill. Arnhall Business Park is recognised as a Subsea Centre of Excellence and the Park is home to a variety of Energy sector and associated occupiers. Abercrombie Court is accessed via the A944 from Aberdeen city centre and the Westhill junction of the AWPR is in proximity.

DESCRIPTION

The Suite comprises a regular shaped office suite currently laid out in open plan configuration, with a glazed partitioned meeting room. The suite benefits from painted plaster walls, acoustic tile ceiling with modern light fitments, double glazed upvc windows, comfort cooling and raised access floors. The suite contains a small kitchen area with base and wall units. W.C.'s are in the ground floor entrance and first floor lobby as is a lift to access the first floor facilities. The suite benefits from an excellent parking provision of 5 spaces which equates to a ratio of 1:205 sq.ft.
