Fully approved 43 acre +/- PUD allowing for up to 125,000 Sq. Ft. of commercial/retail space and 175,000 Sq. Ft. for a multi-sports and recreation center. Preliminary site plan calls for two multi tenant retail strip centers, one free standing restaurant, or retail user, and one free standing gas station/convenience store.

Located in St. Johns County, the fastest growing County in Florida, the PUD is located less than 2 miles from The Pavilion at Durbin Shopping Center. The Pavilion at Durbin Park is the first phase of the larger Durbin Park Town Center project, which will include three major anchors, multiple hotels and theaters, and a Bass Pro Shop. The shopping mall, when complete, is expected to be double the size of St. Johns Town Center.




