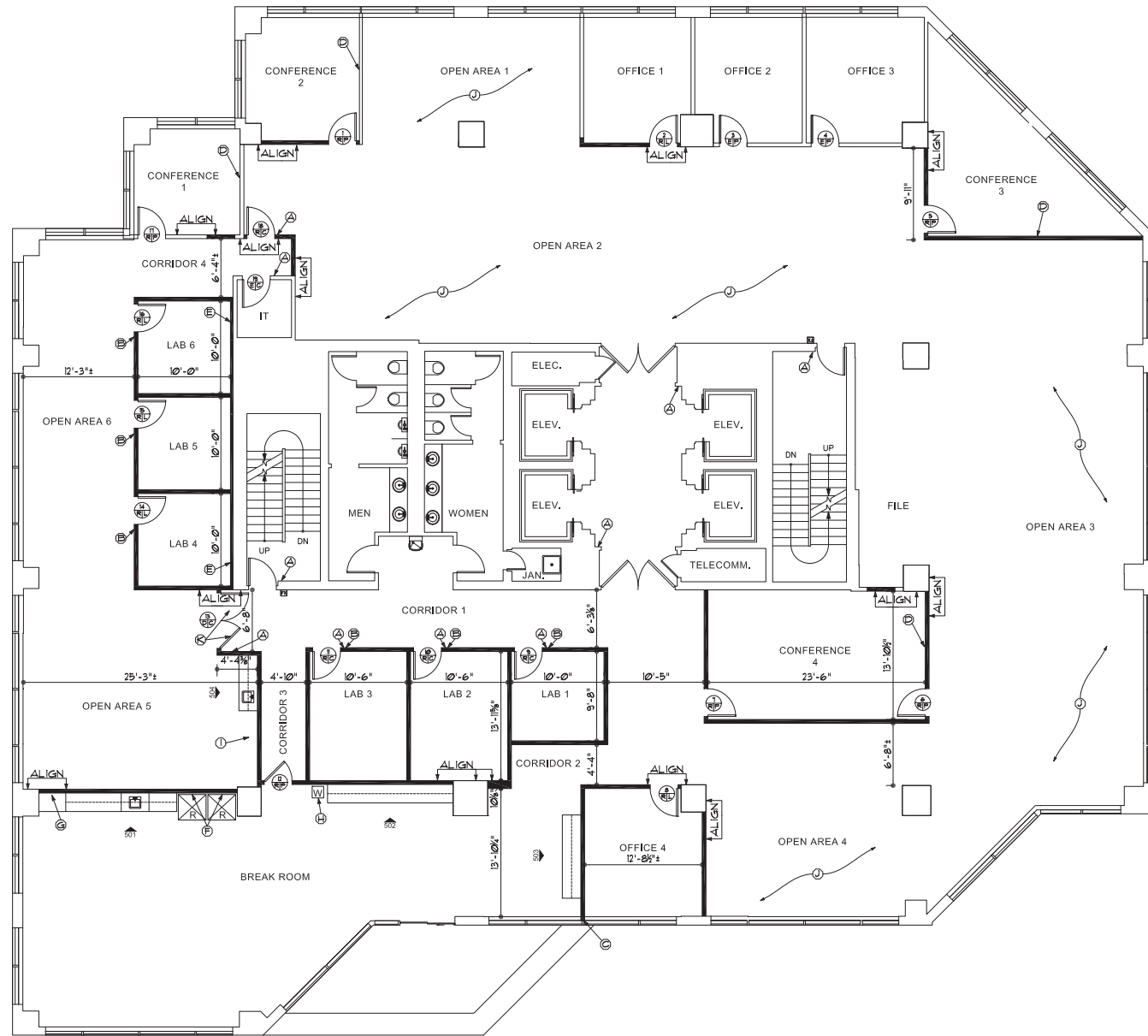

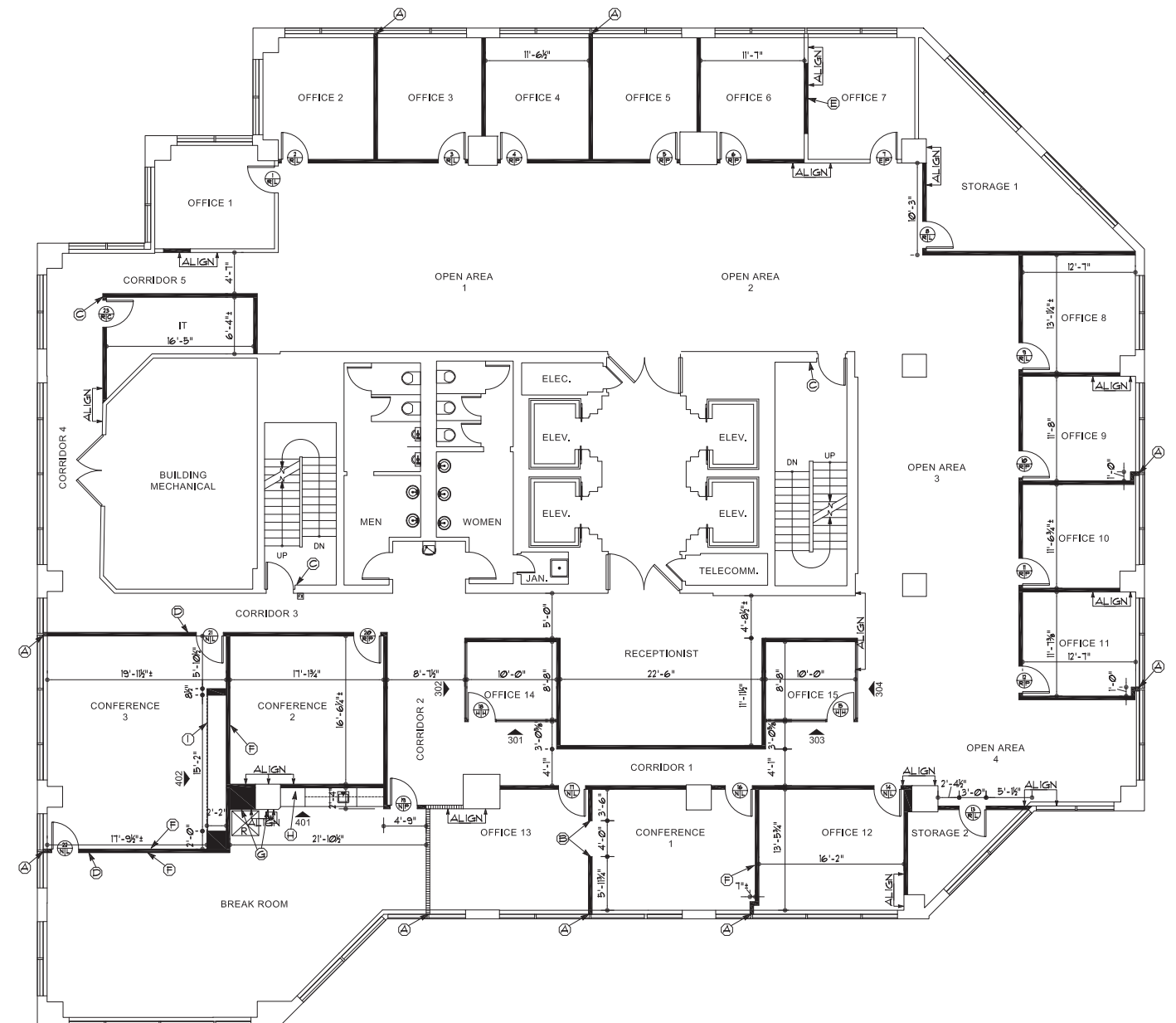

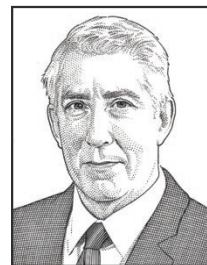
# Floor Plans - Level 9
