Spindles and Town Square Shopping Centre comprises approximately 450,000 sq ft of retail accommodation over two trading levels, providing two multi-storey car parks with 1,370 spaces; and a tenant lineup including H&M, River Island, Next, Debenhams, TJ Hughes, JD, The Entertainer, Boots, Waterstones, B&M and Costa amongst others.

The centre benefits from a weekly footfall in excess of 180,000 per week. Oldham has a catchment population of 217,000 within a 6.5 mile radius and 1.91 million within a 12 mile radius. The primary and secondary catchment totals 518,240.


