



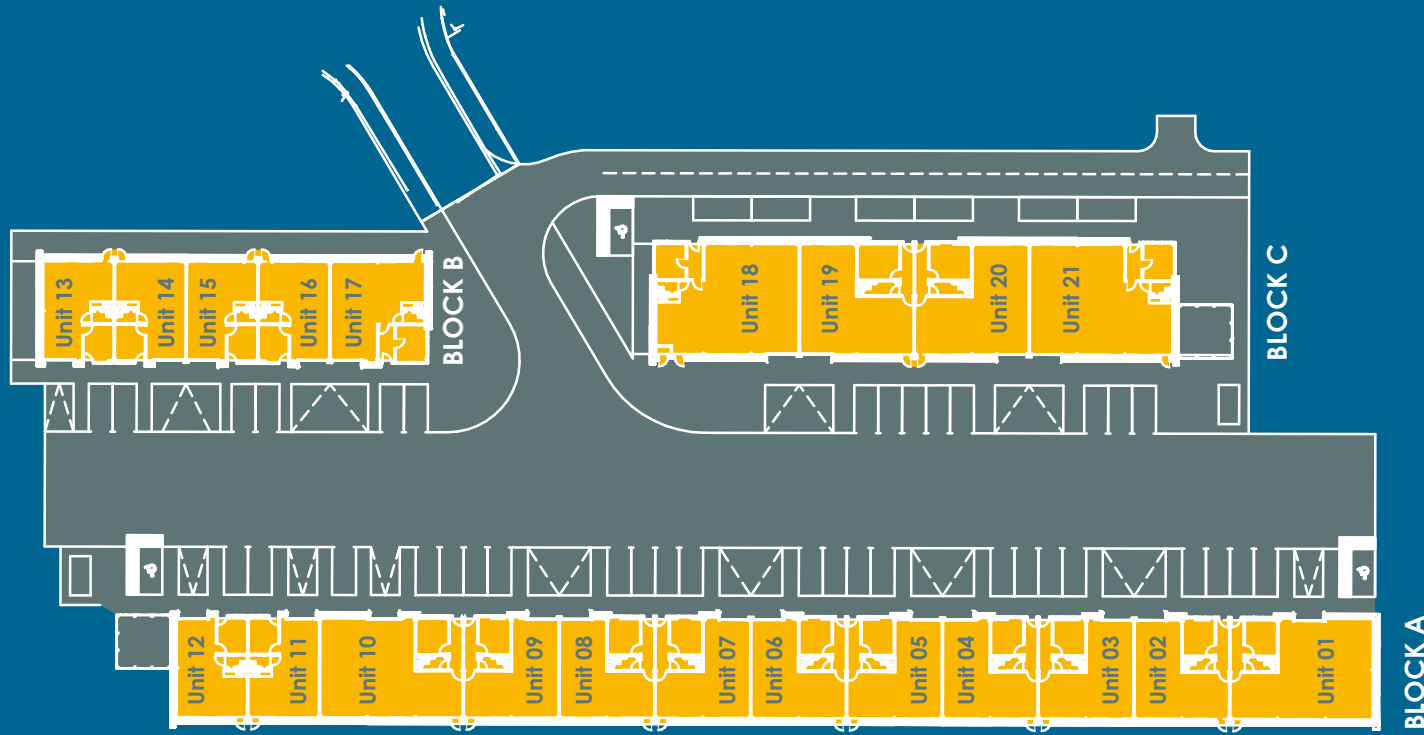

Queens Meadow Business Park extends to some 65 hectares (160 acres) and is already home to modern high class business units as well as the UKSE Innovation Centre providing managed accommodation for new start-up businesses. Description

Enterprise Court is a new development by the Homes & Communities Agency comprising of 21 workshops/industrial units, each incorporating office, WC and kitchen facilities. The units are arranged over three terraces, with each unit having the benefit of parking and loading areas. Enterprise Court is set within a pleasant landscaped environment with estate security provided by a CCTV camera network.

All of the units benefit from a B1 planning consent. An application has been submitted to extend the use to B2 category for units 13-21.

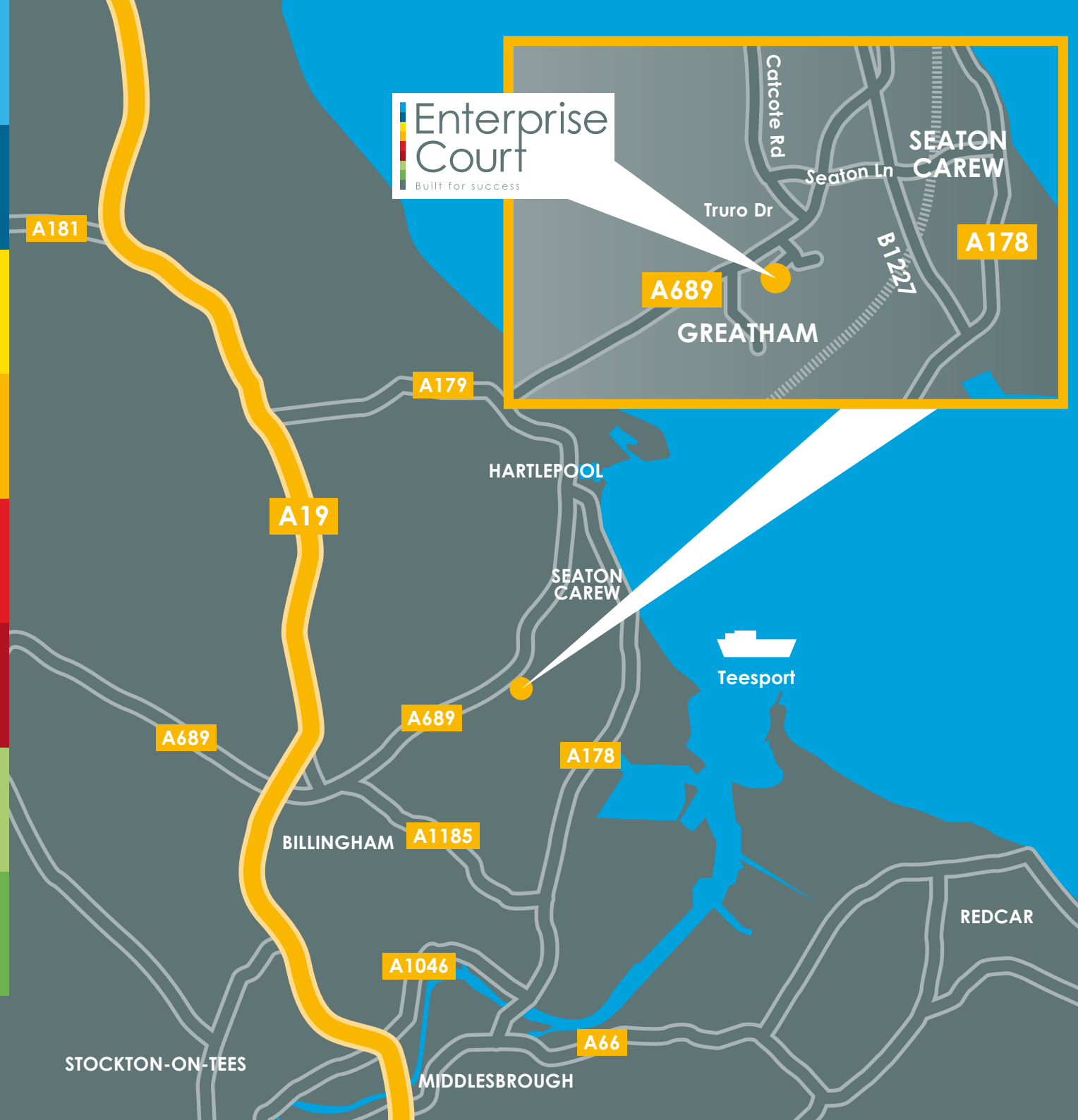
