



**BUILDING TYPE:** The properties comprise 2 new build single storey detached buildings one to provide a café/restaurant and the other a shop. The new buildings will form part of a new build development comprising 100 residential units.

The café building will be built to a shell specification ready for an incoming tenant's fit-out. A floor plan showing a typical café layout is provided within these marketing particulars for indicative purposes. 

Cafe NE Elevation




Cafe NW Elevation

Cafe Plan 1:100


INDICATIVE FLOOR LAYOUT.






# Shop Plan
