#### Location

Portadown is situated approximately 23 miles south west of Belfast and 20 miles north of Newry. It is served by excellent transport links, and is strategically located just off the M1 motorway.

The town population is over 28,000 people, with a catchment of over 120,000 people within a 15 minute drive time.

#### Description

Meadows Centre is a 130,000 sqft scheme in the heart of Portadown which has been revitalised by the opening of The Range in a new 57,800 sqft anchor unit complementing the existing 58,865 sqft Tesco store.

Other retailers within the centre include O2, TUI, Card Factory, Refan / Bomb Cosmetics, Marie Curie, Riverside Health & Beauty and McDonalds. The centre benefits from 630 free car parking spaces.

The average footfall at the centre is now approximately 50,000 customers per week, and we anticipate that this will increase significantly during peak trading periods.

#### Accommodation

The remaining unit is prominently located adjacent to the entrance to The Range.


