

## LEGAL DESCRIPTION

Being a 2.968 acre tract of land in the B.B.B. &C.R.R Survey, Abstract No. 180, City of Lewisville, Denton County, Texas and being Lot 2, Block A of the Final Plat of TRINSIC CASTLE HILLS ADDITION to the Extra-Territorial Jurisdiction of the City of Lewisville, Denton County, Texas, according to the Plat recorded in Volume 2012 Page 256 of the Plat Records of Denton County, Texas and being more particularly described as follows:

POINT OF BEGINNING at a Brass disk set in concrete (Texas Department of Transportation) at the most southwesterly end of a corner clip at the northwest corner of the present intersection of FM 2281 known locally as Old Denton Road (a variable width right of way) and the north line of FM 544 known locally as Parker Road (a 120' width right of way) and being the southeast corner of Lot 2 Block A of aforementioned addition;

THENCE South 89 Degrees 12 Minutes 15 Seconds West with the north line of FM 544, a distance of 472.32 feet, to a 5/8 inch iron rod with cap stamped Adams Survey RPLS 5610 found for corner in the east line of Lot 1 Block A of said Trinsic Addition and continuing with east and south line the following courses and distances;

THENCE North 00 Degrees 02 Minutes 15 Seconds East, a distance of 262.31 feet, to a scored "X" found on top of stone column for corner:

THENCE North 89 Degrees 57 Minutes 21 Seconds East, a distance of 503.38 feet, to a 5/8 inch iron rod—with cap stamped Adams Survey RPLS 5610 found for corner in the west line of FM 2281 a variable width right of way;

THENCE South 01 Degrees 57 Minutes 31 Seconds East with said west line, a distance of 45.62 feet, to a 5/8 inch iron rod with cap stamp #1890 for corner and being on the west line of that 12'R O W DEDCIATION PER PLAT OF TRINSIC ADDITION and continuing the following courses and distances;

THENCE South 04 Degrees 08 Minutes 28 Seconds West, a distance of 110.68 feet, to a 5/8 inch iron rod with cap stamp #1890 for corner.

THENCE South 01 Degrees 54 Minutes 11 Seconds East, a distance of 71.78 feet, to 5/8 inch iron rod with cap stamp #1890 for

THENCE South 43 Degrees 46 Minutes 32 Seconds West, a distance of 39.36 feet, POINT OF BEGINNING having an area of 129,297 square feet or 2.968 acres
